This property can be utilized in current state or with a little work the pastures can be cleaned up into tillable acres to add to the productive acres. There is also a home located at 302 S Hasting St in La Plata, MO that is directly across from the La Plata Golf Course.



### TRACT 1: 18.9 ± ACRES

Offering 18.9+/- acres with FSA figures showing 16.75 acres of productive cropland, excellent access from the North and West, this smaller parcel would be ideal as an add-on tract to an existing tillable operation.



### TRACT 2: 80 ± ACRES

Ideal deer hunting/recreational tract! This parcel offers 80+/- acres and this property will offer excellent deer and turkey hunting, great access from the West side, and FSA figures show 38.84 acres of crop land that could be cleaned up and farmed or utilized for food plots.
